Comscore Markets[™] License Agreement

This Comscore Markets License Agreement ("License") is by and between Comscore and the entity agreeing to this License ("Client") and is effective on the date accepted, including, if applicable, by executing a written form referencing this License or by clicking an acceptance box or button, by which action you confirm your authority to bind Client to this License. You must not accept this License if you do not have that authority. If you and/or Client are a competitor to Comscore, you may not accept this License without our written permission. By accepting this License the Client accepts, without need for further action, the Terms of Use at: https://www.comscore.com/Request/other/Terms-and-Conditions, which are incorporated herein by this reference. Defined terms herein have the meanings given to them in the Agreement unless otherwise specified. In the event of a conflict between the terms in the Agreement and the License or other terms herein, the License or other terms herein shall control with respect to Comscore Markets use.

Comscore Markets. To improve upon traditional boundaries of the television marketplace which no longer adequately represent viewing consumption, Comscore introduced Comscore Markets ("CM" or "CMs") to better address industry needs. CMs leverage 210 local market definitions and universe estimates created using Comscore proprietary methodologies. Due to the changing nature of technologies, methodologies and regulations associated with the matters covered herein, including but not limited to data rights and data privacy issues, Comscore may amend the Product Terms associated with use of CMs from time to time, and, and Client is encouraged to review the Product Terms regularly to review changes that may have occurred including those pertaining to use of CMs.

Limited License & Restrictions. Comscore grants Client a revocable, non-exclusive, non-assignable, nonsublicensable and non-transferable license to use the CMs for its confidential and internal business purposes only, for the limited purpose of matching Client data to CMs when performing aggregated geographic location analytics (the "Limited License"). To the extent Client's internal business purposes entail use of CMs for its direct customers (e.g., advertising agencies' use on behalf of their advertising clients), then this Limited License extends to use of CMs for such purpose, so long as Client confirms that each such customer maintains or acquires their own active CM license before commencing such use. Client represents and warrants (A) that it shall not (i) sell, resell, license or transfer the CMs or this license thereto, including for any type of commercial value or gain whatsoever; (ii) reverse engineer or attempt to reverse engineer the CMs or any Comscore model or methodology; (iii) make any unapproved modification or create any unapproved derivatives: (iv) use the CMs for the purposes of marketing activation or

individual targeting, or in any manner that could knowingly or inadvertently locate specific individuals or target communications to them; (v) derive or attempt to derive any personal information from the CMs, or otherwise use them for individual attribution in any manner; (vii) unless responding to a subpoena or other valid process, introduce the CMs or derivatives thereof as part of an investigation or court proceeding; or (vii) knowingly use the CMs in a manner that creates any third party cause of action or liability on the part of Comscore, its Affiliates or licensors, and (B) that any of its methodologies and/or platforms that utilize any information provided hereunder shall output only deidentified and non-personal information. Client is responsible for ensuring that all use of the CMs complies with this Limited License and for seeking advance written permission signed by an authorized Comscore executive for any use not expressly authorized.

<u>Additional License-Scope Limitations</u>. Use of CMs is limited to active subscribers to Comscore TV products, and Client acknowledges that it must maintain an active subscription to Comscore; except for the limited license CMs. CMs and all data contained therein are owned by or licensed to Comscore; except for the limited license to Client set forth herein, no transfer is made of any intellectual property or other right associated with the CMs or derivatives thereof (including but not limited to: copyright, trademark, patent, business method and process rights, and database rights). In addition to the restrictions set forth herein and in the Agreement and Product Terms, Client also agrees, represents and warrants that it shall not use the CMs for commercial or economic benefit in any manner, including but not limited to any purpose that is competitive to Comscore; for clarity, such use exceeds the scope of this Limited License, and such use is prohibited unless Client has obtained and maintains an active commercial-use CM license signed by an authorized Comscore executive which expressly allows such use.

<u>Updates</u>. Client acknowledges that CMs will be updated from time to time and understands that use of the most recent version of CMs is necessary to obtain optimal results. Client therefore understands the benefit of checking for and implementing updated CMs when available, and to visit the Comscore website at least once each calendar quarter for such purpose.

<u>Term & Termination</u>. The term of this License shall commence when accepted in the manner set forth in the preamble above and may be terminated at any time by either party with or without cause. Termination shall be effective 3 days after notice of termination is provided. Notice to the Client is sufficient if e-mailed to the e-mail address provided by the Client when accepting this License.

<u>Public Release</u>. When referencing information or reports that make use of CMs, Client shall provide attribution to Comscore and otherwise conform to the terms of the Agreement and to the usage guidelines set forth at <u>https://www.comscore.com/Insights/Data-Usage-Policy</u>. The agreed attribution shall state: "Comscore Markets™ information is used under License, and further use, reproduction and/or distribution of this information is subject to appropriate licensing and express approval from Comscore."
